Executive Director Report

Each year brings its own set of successes and challenges that keeps our work in drowning prevention interesting and motivating. It was no different in 2019.

Early in the year, recognizing the need for more lifeguards throughout the Branch, the Lifesaving Society initiated a presence at 5 Career & Education Fairs in collaboration with Red Cross. Many Affiliates supported us with handout materials and personnel to man the booths. With the great interest shown by students attending the fairs, we hope to see more recruits and more applicants in the future for the

fulfilling jobs that aquatic recreation provides.

The program component of the Branch was overly active as always with ongoing development of leadership courses and resources as well as preparing for Bronze revisions. The Program Advisory Group has provided great support for the tireless work, expertise and energy we see from our Education Director, Brooke Cherfils in leading the group by ensuring integrity and high quality programs.

Safety management services continues to grow through the provision of an increasing number of audits as well as enhanced program offerings. We continue to benefit from Cheryl Sibany's experience and passion for safety in pools and on waterfronts. Her leadership in developing Lifesaving Sport also culminated in the Branch becoming recognized as the Provincial Sport Organization, a significant milestone.

In support of the Swim to Survive program, we were most pleased to receive a \$10,000 grant from the YVR for Kids Foundation. This allowed us to provide 12 communities with kits containing materials to provide Swim to Survive training to community members of all ages. The response was overwhelming with all recipients keen to make the most of the opportunity.

The 2019 edition of the biennial Ripple Effects Provincial Aquatics Conference was a resounding success with a record number of over 150 delegates attending. As a partner in the conference, the Lifesaving Society played a prominent role with a very active booth as well as many speakers either representing the Society or referencing our programs and safety management services.

And while we hold our collective breath each year hoping there will be no drownings, we came closest ever to that goal in 2019 with what preliminary numbers show will be under 40 drownings. We hope that people are being more WaterSmart and taking note of our public education messaging and training but whatever the reason, the trend is certainly a positive one that we hope will continue.

I wish to acknowledge the hard work of Branch office staff through 2019, especially in light of having one less full-time position and having many new challenges to address. We are fortunate to have a highly committed and skilled staff team that is very much supported by a cast of loyal volunteers. My sincere thanks to all of you as we continue to strive toward a Canada free from drowning in 2020 and beyond.

Education Director Report

Building on past progress, the momentum of program development in 2019 was again moving at a fast pace.

March training and subsequent mentoring saw the culmination of National Trainers being certified in each region of the Branch. They are now committed volunteers representing the Branch and helping to support and mentor Instructors and Trainers in their region as we work towards a robust Leadership compliment throughout the province and territory. National Trainers additionally provide program quality assurance as well as regional program-related Affiliate support.

They are a dynamic and skilled team that will continue to ensure excellence in our program delivery.

Program Advisory Group Co-chairs, Kyle Kronebusch and Krista Mueller, continued to do an excellent job of keeping the group on track and meeting important project timelines such as launching the National Competency-based Leadership system. It was a paradigm shift for many that needed some coaching and adaptation but was mostly appreciated as a positive step based on current educational practices and encouraging instructor accountability.

We were excited to launch our new First Aid Programs on July 1, 2019 with many Affiliates picking them up to provide the lifesaving knowledge to their patrons. There is a new look and feel to the resources for candidates as well as increased teaching aids for instructors. As a result of the positive relationship built with WorkSafeBC through the process of obtaining OFA equivalency, the Branch was invited to provide input to revise WorkSafeBC Program Standards. We also provided input to the Ministry of Health during their process of updating child and residential care legislation.

In anticipation of the 2020 launch of a revised Bronze Cross to serve as Assistant Lifeguard training, this year saw a review of the National Lifeguard program to ensure it is current and aligned with the revised Bronze Family. The Assistant Lifeguard designation is an exciting step forward to help stimulate the training of new lifeguards.

An advance in the National Lifeguard program saw all NL Instructors certified as Recert Conductors, thereby eliminating the need for a separate clinic (certification). NLI recertification also included a heightened focus on scanning and observation skills as well as more emphasis on most effective lifeguard positioning and rotation.

In closing, I wish to highly commend the collaboration and teamwork shown by our National Trainers, Program Advisory Group members and so many other committed volunteers who act as champions of our work in providing the best lifesaving programs possible. We could not do it without you!

This is a transformative event that will allow us to grow the sport with professional expertise from British Columbia's sports leader.

We invite athletes, coaches and parents to participate in exciting events during the upcoming year such as the Junior and Open Pool and Waterfront Competitions as well as the revival of the once famous Open Water Swim event. As a result of the work and promotion by the Lifesaving Sport Advisory Group (LSAG), the Branch has now registered over 20 Lifesaving Clubs for the 2019-20 season. A special thanks for the leadership of Anita Chevalier (Chair) and the LSAG team in accomplishing this objective.

Early in the year we are also looking to fill the 2020 Lifeguard Competition calendar with regional competitions as well as hosts for the 2021 events. Regional competitions were very strong in 2019 with many first-time competitors experiencing the fun and learning inherent in these events. Congratulations to all those who organized and volunteered at regional events, supported by the expertise of our Competition Chair Kim TownSchon and the Competition Committee.

Unfortunately, we were unable to run the Barnsley Branch Lifeguard Championship in 2019 despite having the City of Richmond step forward as host. As a result of feedback received, the 2020 edition will move to an early Spring date and the program of events will be condensed into a single intense day of competition. A huge thanks to the City of Vancouver for stepping up to host the 2020 Barnsley Branch Lifeguard Championship on Saturday, March 28 at the stunning Hillcrest Aquatic Centre.

Train With Purpose



Aquatic Safety Management

In 2019 the Branch continued to add to the suite of Aquatic Safety Management resources available to our Affiliates and all pool and waterfront owners and operators.

Supervision Evaluation and Enhancement (SEE) auditor training was added to all National Lifeguard Instructor courses to create a team of SEE instructors for all Affiliates. It is exciting to witness the growth of expertise in our leadership award holders.

After much development work through 2019, we will soon

launch the new Aquatic Manager Training (AMT) course in April 2020. This course is designed to provide important up-to-date information to pool managers without an aquatics background and to those returning to this area of recreation management.

Through great Affiliate collaboration, we are pleased to also be able to provide a new inservice training package entitled The Impact of Drowning. It is available to Affiliates at no charge and was jointly developed through resources shared by the Ontario Branch and assistance from Kimiko Young and the Aquatic Management Team at the City of Delta.

Aquatic facilities in the BC & Yukon Branch are proactive in their approach to managing risk. In 2019 the Branch completed safety audits for 10 swimming pools, 1 waterfront, a Pool Safety Plan review and an architectural plan review, as well as completing several SEE Audits. Our thanks to all those Auditors, Inspectors and Apprentices who worked so hard to complete these projects.

The BC & Yukon Branch contributes to the National Aquatic Safety Standards Commission by participating in the development of new standards. These are available on the Lifesaving Society national website. Our thanks to Past President Sean Healy for his continued contributions to this important work and representing the Branch as a member of the National Commission.

The Branch Aquatic Safety Standards group of experts includes Sean Healy, Denise Yoroff, Past President Tony Toriglia, Ruth Depew, and Melina Sweezey led by Chair (also a Past President), Len Manuel. This group has been hard at work reviewing, revising and creating new documents in 2019 including the revised BC & Yukon Waterfront Guidelines. Their work and commitment to aquatic safety is highly valued and much appreciated!

 - New Instructor Resources
- First Aid Instructor Transition/Recertification (2019-2022) Resources
- Review of the new Leadership First Aid Instructor course pilot
- Research on Lifeguard Liability

The work of this group and the expertise provided in supporting continual development and upgrading of Lifesaving Society programs is essential to ensuring their quality and value to the field of aquatics. Close collaboration with staff in accomplishing this objective is invaluable.

Competition Committee Report

It has been another interesting year for competition with regional comps thriving, but interest at the Branch level declining. Regrettably, the Barnsley Branch Lifeguard Championship had to be cancelled in August, something we hope to avoid in the future through input from competitors and judges as well as a review of scheduling.

In discussion with Branch office staff, as well as input from athletes and judges, the Committee is continuing to make changes to improve interest and revitalize competition such as:

- All athletes and judges will continue to be required to register, either through a previous event or by preevent registration package allowing better tracking of active participants and improved communication.
- Officials training will be rolled out in 2020 allowing them to maintain a level of certification to be considered for specific roles. Details will follow as the roll-out begins.
- The Barnsley event will now be one day event with no Preliminary situations; all events will be finals (except Individual First Aid). This should reduce the commitment required by athletes and judges in the hope of increasing participation.
- As implemented in 2018, Bronze Cross candidates will continue to be able to participate in the Barnsley Championship (some restrictions apply). This will match the roll-out of the Assistant Lifeguard in 2020 and should increase the number of potential athletes.
- The Simulated Emergency Response Circuit aggregate will continue to be based on the Barnsley event. Each 'year' of the circuit will start after Barnsley and proceed until the next Barnsley event. All eligible Regional competitions will continue to qualify for the Circuit allowing calendar space to spread out events or run them at different times of year.
- Branch competition dates will be adjusted to better align with their equivalent national championship to all Branch teams to be better prepared, such as:
 - Barnsley Championship to move to early Spring allowing teams more time to focus on regional competitions and training prior to the Branch Championship.
 - Perks Cup will run in Spring
 - Schon Cup will run in late Summer
- Junior Lifeguard events may be held to coincide with Branch Championships to help bolster participation until running a separate event is feasible. This will help both streams of competition grow and help link the progression of athletes and judges.
- A Committee will select the Team to represent the Branch at Nationals using clearer selection criteria to ensure a transparent process.

As always, the volunteers on the Competition Committee are committed to fostering competition in BC & Yukon. We are always looking for help, either with a project or by joining the Committee. If you are passionate about competition and want to help shape the future of the sport in our Branch, let us know. Send inquiries and comments to guardcomps@lifesaving.bc.ca.



WaterWise Team

WaterWise Team Celebrates 20 Years with Record Numbers

The 2019 WaterWise Team members included returning 2018 member, Brock Sampson and new addition, Rebecca Robertson. Each added their flair to an impactful 20th season for this important outreach component of the Lifesaving Society's public education campaign.

Reaching thousands of people each summer, the Team travels widely from May to August providing free water and boating safety education to the public through school presentations, high profile and community events, marina visits, seminars, and media coverage.

In May and June, the Team focused on giving presentations to over 7,600 students at 37 schools throughout BC. In addition to school presentations, the Team also attended over 20 community events throughout the months of June, July, and August. When the Team was not presenting or attending events, they could be found offering pleasure craft courtesy checks with support from Transport Canada, visiting local pools in support of the Lifesaving Society Affiliates or at the office preparing for these activities and responding to e-mails.

For the first time in over five years, the WaterWise Team traveled out to the Kootenays to provide Swim to Survive public education and participate in community events in four different Kootenay communities where they received a very warm welcome.

This year the WaterWise Team attended the Richmond Maritime Festival for a day, which was a hugely successful event in the picturesque Steveston area of Richmond. There, the team connected with the Washington State Marine Law Enforcement and continued to share their safety message with the public.

Training and a joint patrol with Transport Canada also saw the WaterWise Team help to provide over 100 safety checks as part of the Pleasure Craft Courtesy Check (PCCC) program at Hayward Lake, Buntzen Lake, Cates Park and Vanier Park.

This year, the WaterWise Team also had the opportunity to partner with KidSafe to provide WaterWise Wisdom presentations at their summer camps in Vancouver to vulnerable children and youth. Many camp groups were heading to the beach later in the wee, so the presentations were very timely.

The 2019 WaterWise Team had a lot of fun meeting new people and talking about what they love ---- having fun and being safe on the water.











National Trainers

The role of a National Trainer has three key components:

- Preparing candidates to assume a leadership role as Lifesaving Society Trainers and Instructors.
- 2. Regional program related Affiliate support.
- 3. Regional program quality assurance.

Each National Trainer is assigned to one (1) of our six (6) regions. Additionally, each National Trainer is assigned to specific Affiliates in their region so that they are able to liaise with the Branch office to offer the best support for their unique challenges. National Trainers work as a team to train, mentor and oversee the Leadership Development Plans for Instructors and Trainers in their region. For this reason, they will often be referred to as Regional National Trainers on Training Packages and in literature.


