A few brief highlights of the year must include reference to the 102nd annual Honour, Rescue and Bravery Awards held on March 29, 2014 where, along with Her Honour Judith Guichon, Lieutenant Governor of British Columbia, we celebrated and recognized individuals for their acts of bravery in the conduct of water rescue in sometimes harrowing circumstance. We also recognized the long and deserving service of various volunteers who individually and collectively ensure that our Society continues to be Canada's Lifeguarding Experts, leading the effort against drowning and accidental injury in and around water.


A key success of the past year was National Drowning Prevention day held in July. As part of our public awareness program, the Society partnered to create 75 'Sand Angels' on the beach in English Bay. This visual representation of British Columbia's drowning victims from the previous year was a stark and powerful message of not only the risks associated with the water but also the need for lifesaving training. This message was transmitted through major media outlets throughout the Province further raising awareness of the drowning problem.

Looking forward, I am pleased to report that the BC & Yukon Branch, with support from the National Lifesaving Society, was selected to host the 2017 World Conference on Drowning Prevention. This biennial conference, run under the auspices of the International Life Saving Federation (ILS), will bring to Vancouver national lifesaving societies, researchers, experts, governmental and non-governmental organizations to present and discuss the newest research and thinking in drowning prevention, lifesaving sport, and related fields.

In closing, it is clear that the past year has been a significant success due to the ongoing active contribution of our membership. I look forward to continuing to work with you and supporting you in achieving the mission of our Society.

EXECUTIVE DIRECTOR REPORT



A milestone year for a flagship program and other highs and lows marked another year of work toward drowning prevention in BC & Yukon in 2014.

It's hard to believe that the National Lifeguard program celebrated 50 years of existence. Originally developed through collaboration of several national organizations, the Lifesaving Society continues to be the standardsetting agency for lifeguard training in Canada. The safety and rescuereadiness they provide for the swimming public is highly valued and critical to meeting our drowning prevention mandate.

In January I spoke at the annual Municipal Recreation Administrators' workshop in Harrison. It was a great opportunity to chat with municipal recreation decision-makers to let them know more about the Society's work and to thank them for their support in running our programs in their aquatic facilities.

We were saddened to see the passing of two Past Presidents, both in February. Ellen Lloyd was Branch President from 1987 to 1992 during a challenging time, but her perseverance and leadership will forever have her seen as an important builder for the Branch. Ellen was also a key player in hosting Rescue '86, a major international event for which this Branch is still remembered.

Jean Lathwell passed away at the age of 94 but lived life to the fullest and was a wealth of history on the Society. When I started this job I was told that at least one day of history from Jean was a mandatory part of my orientation. She was a favourite with the lifeguards at their competitions not only because of her many stories and history of the Society, but also because she was usually first on the dance floor. The guidance and passion of both these amazing women will be missed.

February also saw the initiation of a Coroner's Panel to review 35 child and youth drownings between 2007 & 2013. I sat on the panel that came out with 3 main recommendations: messaging to target male youth, messaging specific to parents regarding child supervision and the support for a province-wide by-law to enforce 4-sided fencing around backyard pools. The Lifesaving Society then collaborated with Red Cross and Preventable.ca to address how we might proceed to answer to these recommendations. Some great ideas came up that will be worked on in the months to come.

Summer was busy as drownings began to occur and the Lifesaving Society was again prominent in the media to help spread the safety messages. Exposure was assisted thanks to the creative work of Taxi ad agency with their development of the Sand Angels event on English Bay in July.

As if to continue building on the legacy of those who have gone before, we submitted a bid to host the 2017 World Conference on Drowning Prevention. I was honoured to attend meetings in Montpellier, France in September to make a successful pitch to the International Life Saving Federation's (ILS) board of directors. Although still over two years away, there is much work to be done and many helping hands will be required to make it as memorable world-wide as Rescue '86 is today. We look forward to welcoming many of you as part of the team.

Thanks to many passionate volunteers, the competition season went well and finished with a unique outdoor Barnsley Branch Championship at Brock Pool in Kamloops. Kim TownSchon and his team did a fine job of running the event supported by Heidi Ogilvie and her Kamloops staff.

Branch staff wrapped up the year with a fun-filled night at Giggle Dam's comedy theatre, a welldeserved reward for a hard working group. My heartfelt thanks go to them for making my job easier and making each day at work so enjoyable. Our mandate of saving lives is serious business, but with such a committed team of staff and volunteers we continue to have an impact on safety around water.

PROGRAM AND PUBLIC EDUCATION REPORT

In 1964 the Lifesaving Society was appointed the caretaker of the lifeguard training program and to this day has endeavoured to maintain the highest quality, research-based program in the country and around the world. All candidates who were certified in 2014 received a commemorative sticker along with their certification card to help celebrate the program's 50th anniversary.

This past year, the Leadership Committee and the Branch office worked closely to develop a variety of Canadian Swim Patrol resources to include lesson plans, activity sheets and progress cards

for each of the CSP levels. We would like to thank Monica Sicotte (Leadership Chair) and her team in the development of these resources and wish Monica the best in her new role of Standards and Safety Manager with the Alberta & Northwest Territories Branch.

National Leadership revisions for LSI, LSIT, NLI and NLIT programs are now nearing completion. The new National Leadership program is based on Blooms Taxonomy, a competency-based approach to education that includes technical, behavioural and physical competencies. Part of the revision will include an Award Guide for all National Leadership programs and a new Instructor resource.

The First Aid Instructor Recert clinics were the only Leadership Recerts held in 2014. The focus was on streamlining the program by making all First Aid Instructors stand-alone AED Instructors and CPR-HCP Instructors under one certification. In addition, First Aid Instructors will now be able to recertify when their award expires rather than being locked into the mandatory Recert window.

Drowning Prevention Week was held from July 19th to July 27th and kicked off with a public education campaign that featured 75 'sand angels' on English Bay to represent each drowning death that occurred in 2013. Affiliates were encouraged to take a 'family' approach to water safety by setting up activity stations provided by the Society that would be appropriate for both children and adults. These stations focused on activities that would target the current drowning statistics.


In fall of 2014, I was fortunate to be able to attend both the ECCU (Emergency Cardiovascular Care Update) Conference in Las Vegas and the World Aquatic Health Conference in Portland, Oregon. Affiliates and Instructors can expect to see some of the information from both conferences to be included in the 2015 Leadership Recert cycle and BCRPA Ripple Effects Aquatic Conference.

In 2014, the Branch office continued its working relationship with Affiliates through site visits, the Aquatic Safety Audit Program and by participating in the annual Aquatic Programmer Development Meetings (APDM) and regional Affiliate meetings.

In closing, we would like to thank all of our co-workers at the Branch Office, our Affiliates and the tireless efforts of Society Committee members and volunteers who have played a part in making this another successful year.

SWIM TO SURVIVE



Swim to Survive training prepares children for an unexpected fall into deep water



Once again, thanks to generous contributions from the Province of British Columbia, the RBC Foundation and the Recreation Foundation of British Columbia, the Lifesaving Society has been able to continue its mandate to train Grade 3 students throughout the Branch in the Swim to Survive standard.

In 2014, the Lifesaving Society approved \$50,929 grant funding to train 4,929 Grade 3 students. Of those students, 8% were from the Lower Mainland, 42% the Island, 28% the North, 22% the Thompson-Okanagan and 1% in the Kootenays.

Our goal is to provide at least 50% of Grade 3 children with these important water survival skills to help them deal with an unexpected fall into deep water.

WATERWISE BOAT SAFETY TEAM

The WaterWise Team successfully completed their 15th season, visiting BC's Interior, Vancouver Island and the Lower Mainland providing information at schools, summer camps, boat launches and high profile events.


Through the WaterWise Wisdom education program, the Team was able to promote their water and boat safety messages to 2,774 students, a slight increase over 2013 which was a feat due to the school strike action.

The Team also shared knowledge through public education booths and distribution of various boating publications in their 'Safety Kits' including the SunCruiser Magazine, Discover Boating Magazine, Georgia Straight Alliance's Guide to Green Boating, the AdventureSmart Trip Planner and the WaterWise Team's Safety Checklist.

We were very fortunate to have both Kim MacKinnon and Kim Willox return for a second season as Team members providing their experience and enthusiasm to help spread safe boating education.

Special thanks to Boating BC, the Provincial Gaming Branch and Discover Boating for their on-going support of the WaterWise Team.



Greetings from the Leadership Committee!

Our goal is to equip Lifesaving Instructors to deliver the best possible Canadian Swim Patrol and Bronze Medal programs. Our

focus this past year has been on developing practical and useful tools to enhance the Canadian Swim Patrol Program. Three of the resources we developed are lessons plans for Rookie, Ranger and Star Patrol. Just like the Bronze lesson plans we developed the previous year, these resources include timelines, sample long term lesson plans, activities for each item and notes to help instructors focus on key messages.

Our committee also created a series of age appropriate activity worksheets based on the CSP knowledge and first aid content. There are ciphers, fill-in-the-blanks and crossword puzzles, along with answer keys, that can be sent home with students to reinforce the learning. We included printable flashcards that can be incorporated into games and relay races to make preparing an engaging lesson that much faster and easier for the Instructor.

Although these resources were intended to work specifically with the program, individual pages can easily be printed for school programs, a water safety education event or for pick-up from a display table. All resources are available to download on the Lifesaving Society webpage from either the Lifesaving Instructor or Branch Affiliate Groups. We encourage you to explore the resources, print them, use them in whatever way inspires you and let us know what kind of impact they have had.

Another new resource that you can find on the webpage is a Parent Letter which gives an overview of the course content, highlights the importance of taking the program and introduces them to the Lifesaving Society. It is a simple way of linking the parent to the Lifesaving Society and involving them in their child's program.

Many thanks to our committee members as well as to Wendy, our Branch representative, for all your drive and passion for these projects throughout the year. It was inspiring. I will miss each of you but look forward to continuing to work with the Lifesaving Society in a full time role at the Alberta Branch.

BC & Yukon Branch was able to see three of our teams go to Nationals, competing as one BC club. All the teams were able to contribute points to the club, which ended up placing 5th over-all at the Canadian Lifeguard Emergency Response Championship (CLERC). Other notable finishes included Fantastic 4 placing 3rd



over-all in the Water Rescue Event. Well done everyone on Team British Columbia!

This summer's competition season saw a great variety of events, with hosts in the Fraser Valley right through to Victoria! It was great to see such a spread of hosts, as well as teams competing from those hosts (and other) pools. A big thank you and congratulations goes out to all those hosts, who made sure we had some interesting weekend activities. The Committee would like to encourage every facility to host a competition, at some point. Not sure how? Ask someone on the Committee and we would be more than happy to help get you started!

The summer capped off, as it always does, with the Barnsley Branch Lifeguard Championship. This year it was hosted by the City of Kamloops, but the entire event was done outside. It was a first, in as long as I can remember, and everyone seemed to enjoy the challenges that an all outdoor event can bring. Big thanks go to Heidi Ogilvie and the Kamloops Team, who made the event happen. Teams were challenged with numerous simulations including a three part Team First Aid Prelim event, and the Manikin Relay (where only 4 of 10 teams were able to complete the event, illuminating that BC & Yukon still has a ways to go with some of the National swim events). Notable highlights included a first place finish for Johnny Lou in the IFA event, and Fantastic 4 winning almost everything, including this year's Barnsley Championship. It should also be noted that they were this year's Circuit Champions. Well done everyone who competed! The Committee is looking forward to 2015's Championship already; perhaps you are interested in hosting such a prestigious event? Contact the LSS Office for more details.

The Committee continued its push to find hosts and competitors enough to run both the DB Perks Cup and the Schon Cup. Lifeguarding and Lifesaving doesn't need to be pool only. I would encourage everyone to try some of the events that these other championships offer. As we move to become more competitive on a National scale these events will need to run. Prepare yourself and your teammates for National and International Competition by signing up for these 'new' events. For most events only a Bronze Cross is needed, so you don't need to be a swim clubber or beach lifeguard to compete. It never hurts to try new things.....

The Committee is currently working on a few projects and you are more than welcome to provide input. We are always looking for keen, eager people to help us promote competition. Currently the Committee is working on a Branch Lifesaving Competition Manual, similar to what you would see on a National or International level. We are also excited to announce that we will be piloting a Priority Assessment event this year that more closely matches the National event.

In closing I wish to thank everyone who has helped to make Competition what it is again this year. We get here thanks to the countless hours so many of you donate to this incredible sport.

AED AWARDS

The AED Rescue Award is an Affiliate award that recognizes rescuers who have used their Lifesaving Society training under the AED Quality Assurance Program.

The focus of the AED-QAP program includes not only training in effective CPR and on the facility specific AED, but also training in the deployment of the AED to the scene in a timely manner.

Since 2007, the program has grown to include 107 venues that have had a combined total 30

AED deployments, 26 of which were successful. Research has shown that effective resuscitation and the application of an AED within the first few minutes of a cardiac arrest can dramatically improve survival outcomes. This is evident in our 87% success rate, well above the national average.
